

## Customer Privacy Notice

Gentle Customer,

The undersigned Finikem S.r.l., as Data Controller, hereby informs you that, pursuant to article 13 of EU Regulation 2016/679 concerning the protection of personal data (hereinafter the Regulation), for the establishment and execution of Contractual agreements is or may be in possession of information related to you.

### 1. Type of personal data processed

The following personal data may be processed: personal data, tax information, contact details, bank details and other administrative or commercial data necessary for the purposes indicated below.

### 2. Purpose of the processing

The data will be processed for the following purposes: compliance with legal obligations and execution of the contract of which you are a party, fulfillment of obligations towards the Financial Administration, accounting and administrative management, management of existing commercial relations and management of legal disputes.

The data will be processed, also, to be able to send you our newsletter via email.

### 3. Legal basis

The legal basis of the processing is the execution of the contract, the fulfillment of the obligations foreseen by current regulations and the legitimate interest of the Data Controller.

### 4. Data Retention Period

The data will be stored for the period necessary for the pursuit of the aforementioned purposes and in any case not later than the terms foreseen by specific legal obligations.

### 5. Recipients of personal data

Designated personnel, appropriately trained and operating under the authority and responsibility of the Data Controller, will process the data. Some of the information can be communicated to the subjects indicated below: Public bodies (Tax Offices and other entities); Law or consulting firms to which the Data Controller has assigned a specific mandate; Support and maintenance companies of IT systems or digital archiving systems; Other subjects or companies that carry out activities instrumental to the purposes listed above. ### 6. Rights of the data subject

We also inform you that, with respect to the data, you can exercise the rights provided by the CHAPTER III of the Regulation at any time.

In particular, you have the right to request access to the data concerning you, their correction, deletion, or integration of incomplete data, the limitation of processing; to receive data in a structured, commonly used and machine-readable format; to object in whole or in part to the usage of the data, as well as to exercise the other rights recognized to you by the applicable discipline.
